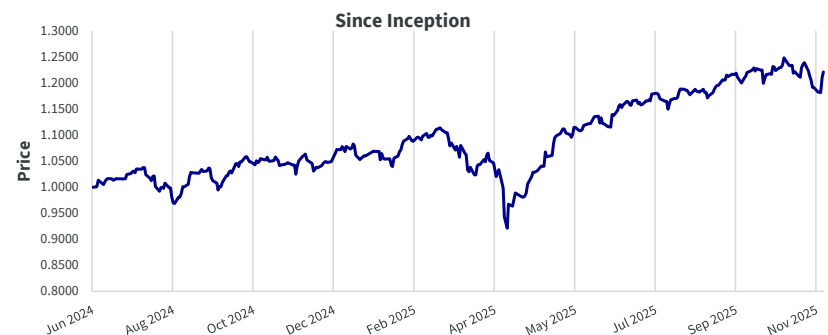

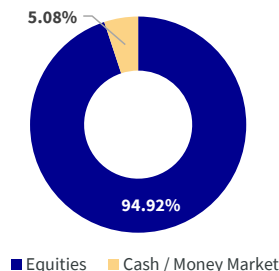
NAVPU GRAPH

MARKET COMMENTARY

Global equities finished the month largely unchanged despite increased mid-month volatility driven by AI bubble concerns. Investors shifted into healthcare and value stocks, while technology stocks faced declines amid valuation worries. Optimism regarding US rate cuts helped stabilize markets, though emerging markets, especially Chinese equities, underperformed. Volatility decreased, with the VIX closing lower, indicating improved market stability. Most sectors within the MSCI ACWI advanced, led by healthcare, materials, and consumer staples, while information technology, consumer discretionary, and industrials declined.
