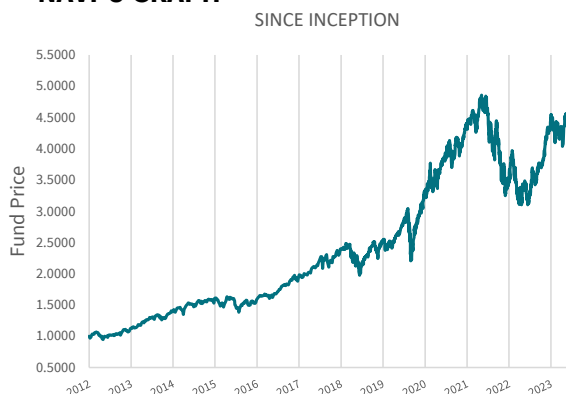

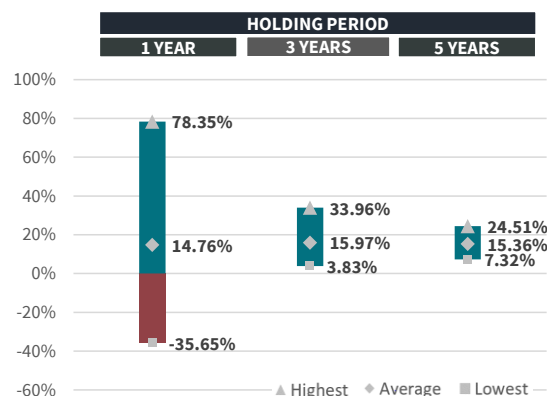

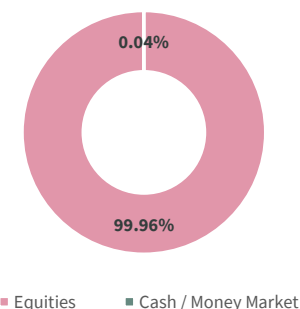
RANGE OF ANNUALIZED RETURNS⁴

This means that if you remained invested in this fund for only 1 year in the past, your investment could have grown to as high as 78.3% or as low as -35.6%.
