Higher risk

Fund risk ratings are calculated based on the historical volatility of the fund in order to match the client's risk profile. A risk profile of 4 matches with the growth-oriented investor, indicating a fund with a medium-high volatility profile (i.e. multi-asset funds).



MARKET COMMENTARY

The Fund delivered positive returns in July as the announcement of several trade agreements by the US administration brought more clarity to the markets regarding tariffs and supported risk sentiment in markets. Developed markets generated positive returns for the period and outperformed their Emerging market counterparts. JP Morgan US Select Equity was the leading contributor to performance for the period benefitting from it's significant cash allocation for the period as the dollar strengthened against the Euro over the month. iShares Core MSCI Europe ETF was the leding detractor to performance as European equities lagged other major markets.
