The Global REIT and Property Income Fund is a unit-linked fund that aims to provide regular cash payout to its investors by investing in a target fund with a portfolio of real estate companies and REITs.

## MARKET COMMENTARY

The Real Estate Select Sector SPDR Fund posted a positive return in January 2026, driven by stabilizing macroeconomic conditions and improving sector sentiment. Property sector valuations remained attractive as stabilizing political and economic factors drove the 10-year Treasury yield lower, providing further upside potential to the sector. However, a recent policy announcement by President Trump to restrict large institutional investments in single-family homes caused a temporary decline in housing-related stocks. Looking forward, easing supply pressures are expected to help reduce headwinds. Preferred subsectors for 2026 include Healthcare, Shopping Centers, and Coastal Apartments, with Healthcare anticipated to demonstrate resilience throughout the year.

### NAVPU GRAPH




