High Risk





## MARKET COMMENTARY

The Philippine equity market ended February on a strong note at 6,611.24, driven by a BSP rate cut, benign inflation, a weakening dollar, and strong corporate earnings. Foreign investors further buoyed the market as net inflows totaled \$285.7 million YTD, while the peso appreciated amid US trade policy concerns. Market gains were led by consumer sectors, with notable performances from Puregold, Monde, Universal Robina, and ICTSI. Financial sector earnings showed mixed results while utilities and telecoms reported stable earnings. However, geopolitical tensions in the Middle East have stalled market revaluation, and domestic political uncertainties—including impeachment proceedings and corruption investigations—continue to pose risks for the outlook into 2028.
