


## MARKET COMMENTARY

Global bonds underperformed riskier assets in January due to improving investor risk appetite and country-specific developments. During this period, Investment Grade outperformed High Yield and government bonds. Neuberger Berman Emerging Market Debt Hard Currency detracted the least from performance for the period benefitting from its increase allocation to IG credit. Conversely, First Sentier Asian Quality Bond was the leading detractor to performance for the period weighed down by its exposure to US treasuries.

Since the target fund is USD-denominated, the return of this peso share class fund was slightly affected by a slight movement between the Philippine peso and the US dollar.


### ASSET ALLOCATION
