


## MARKET COMMENTARY

The Nasdaq 100 declined in February, underperforming the S&P 500, amid sector rotation from growth to value and smaller-cap stocks due to concerns over future revenue growth and increased capital expenditures. Technology leaders like Alphabet, Amazon, and Nvidia reported mixed earnings, with strong AI demand offset by slowing revenue growth in some areas, contributing to market volatility. Inflation showed signs of increasing, while geopolitical tensions, including US-Israel military strikes and Iranian missile attacks, added to market uncertainty. Despite many companies surpassing earnings expectations, investor focus remains on future revenue, profit margins, and capex. The US 10-year Treasury yield fell to 3.93%, with markets closely watching inflation trends, labor data, and Federal Reserve policy outlooks, which indicate only one further rate cut may be forthcoming.

Since the target fund is USD-denominated, the return of this peso share class fund was significantly lower than that of its dollar share class as the Philippine peso strengthened against the US dollar.
