

MARKET COMMENTARY

Philippine stocks experienced modest gains in December, with the PSEi rising 0.51% to 6,052.92, supported by local investors despite a weakening peso. While market sentiment remains fragile due to political risks and uncertainties, investors have begun to pickup undervalued names which drove the December rally. The Philippine economy demonstrated resilience as inflation remains manageable at 1.8%, well below the BSP target of 2 to 4%, with expectations of a rebound in Q4 2025 GDP to end the year at 4.8% driven largely by strong remittances. The BSP has maintained an accommodative stance, with a 125bps rate reduction in 2025 and another one cut expected in 2026.
