INVESTMENT OBJECTIVE

The Fund is an actively-managed fund-of-funds that seeks to provide its investors access to a diversified portfolio of fixed income and equities securities spread across five major regions in the world maintaining a moderate level of portfolio risk.

Fund risk ratings are calculated based on the historical volatility of the fund in order to match the client's risk profile. A risk profile of 5 matches with the aggressive investor, indicating a fund with a high volatility profile (i.e. growth equities).



MARKET COMMENTARY

The fund delivered a positive return in July on the back of strong global equities. Global equity markets rallied as the announcement of several trade agreements by the US administration brought more clarity to the markets and supported risk sentiment. US equities led gains for the period outperforming it developed market peers in dollar terms. Global bond markets saw divergence in performance as government bond yields rose while credit market enjoyed a positive month. During the period, Amundi Russell 1000 Growth ETF was the leading contributor to performance for the period benefitting from their regional allocation. Other notable contributors to performance included Federated Hermes Asia Ex Japan Equity, BlackRock Advantage US Equity, JP Morgan Global Select Equity and NT AC Asia ex Japan Screened Equity. However, Selection European Equity was the leading detractor to performance for the period as European equities lagged other major markets.

¹ Quoted Asset Management Charge is inclusive of Fund Manager, Custodian and Fund Administration fees and VAT. Please note that the target fund of the Fund charges a separate management fee which is included in the computation of the Fund's NAVPU.

²Volatility measures the degree to which the Fund fluctuates vis-à-vis its overage return in a specific period. The lower the number, the more stable the Fund's return is.


NAVPU GRAPH


