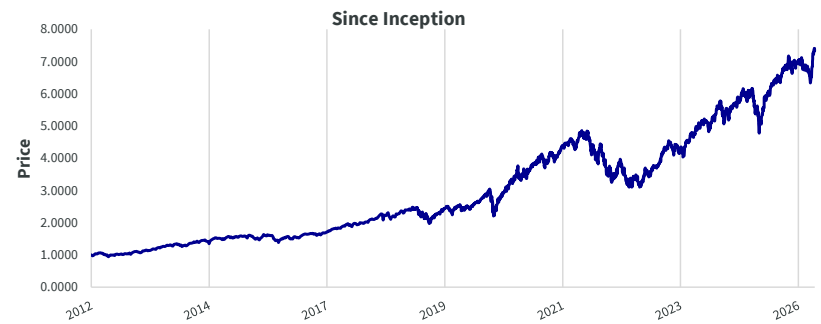

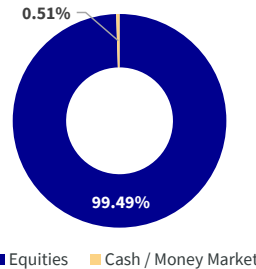

MARKET COMMENTARY

The Nasdaq-100 Index delivered a strong performance in April, outperforming the S&P 500, driven by its technology focus and positive earnings reports from key players like Apple, Amazon, and Alphabet. The index benefited from reduced geopolitical tensions and declining volatility, while the Federal Reserve maintained interest rates amid strong earnings, particularly in AI-related sectors. Intel's remarkable 114% monthly gain highlighted the semiconductor sector's strength, supported by strategic partnerships and robust AI demand. Market outlook remains cautious amid mixed signals from geopolitical developments and oil prices, with upcoming earnings from major tech firms expected to shed light on the ongoing rally. Investors are advised to monitor free cash flow and capital expenditure trends, which are expected to influence future growth and valuation, amid the inherent risks of sector concentration and market volatility.
