Low-Medium Risk

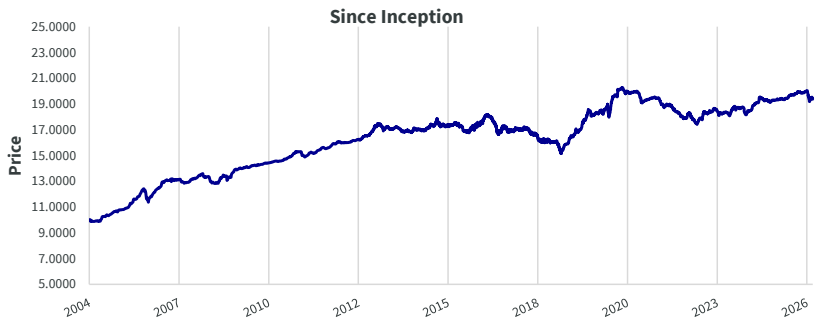

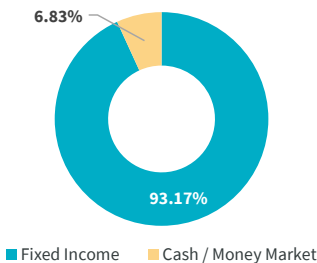

MARKET COMMENTARY

The Philippine fixed income market experienced a mixed performance in April amid shifting geopolitical and monetary policy conditions. Early optimism from easing Middle East tensions and the country's inclusion in a JPMorgan bond index boosted government securities, but this was short-lived as hawkish signals from the BSP and rising inflation concerns led to higher yields. Global geopolitical risks, inflation pressures, and energy market uncertainties influenced market sentiment, with inflation surging to 7.2% and prompting expectations of further tightening. Peso government bond yields generally declined, especially in the short end, though mid-term yields rose. The market remains highly sensitive to inflation trends, policy responses, and external developments, leading to a cautious stance with an underweight duration position to manage volatility.
