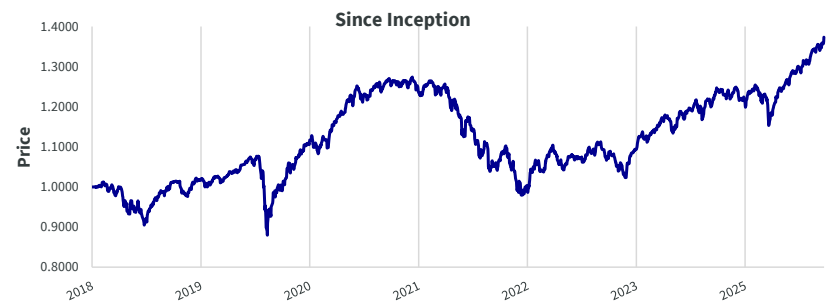

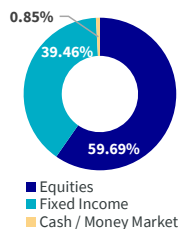
NAVPU GRAPH

ASSET ALLOCATION

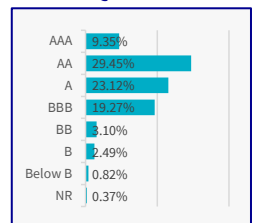

MARKET COMMENTARY

The fund delivered positive returns in October, supported by strength in both equity and bond markets. Global equities rallied on optimism from a Federal Reserve interest rate cut and a strong earnings cycle, with emerging markets outperforming developed markets. Global bond markets also contributed positively, buoyed by the rate cut amid a weaker job market. Key contributors included the iShares MSCI Emerging Market Asia ETF, JP Morgan Asia Pacific Equity, NT AC Asia ex Japan Screened Equity, Blackrock Advantage US Equity, and Amundi Russell 1000 Growth ETF. The Vanguard Pacific ex-Japan Stock Index lagged, mainly due to exposure to Australian equities. Overall, the month reflected broad market gains driven by favorable macroeconomic conditions and sector performance.
